To the Members of Attawapiskat First Nation and Indigenous and Northern Affairs Canada:

We have reviewed the schedule of remuneration and expenses - Chief and Council (the "schedule") of Attawapiskat First Nation as at March 31, 2016. Based on our review, nothing has come to our attention that causes us to believe that the schedule is not, in all material respects, in accordance with Indigenous and Northern Affairs Canada Financial Reporting Requirements 2015-2016.

The schedule, which has not been, and was not intended to be, prepared in accordance with Canadian public sector accounting standards, is solely for the information and use of the First Nation and Indigenous and Northern Affairs Canada for complying with Indigenous and Northern Affairs Canada Financial Reporting Requirements 2015-2016.
